Describing the evolution of women's legal rights in the U.S. from the Revolutionary War to the present, this volume uses biographical sketches of key individuals, summaries of significant court cases and legislative victories, definitions of major concepts, and selected important documents.

A 19-page introduction and a chronology provide an overview of gender equality in the U.S. from colonial times forward. Around 200 entries are arranged alphabetically within broad categories ("Key Historical Concepts and Pioneers," "Constitutional Equality," "Education," "Family Law," "Reproductive Rights," "Violence against Women," and "Workplace Rights"). A comprehensive index, references and further reading lists at the end of each section, and *see also* tags at the end of most entries allow researchers to learn more about each topic. The "Table of Cases" directs readers to the published court texts, and a collection of 21 documents provides relevant declarations, speeches, constitutional amendments, and legislative acts verbatim.

A caveat: editing is sometimes weak. For example, Hillary Rodham Clinton is credited with making history in November 2000 "when she became the first lady ever to be elected as a U.S. senator." "First First Lady" would have been correct. The occasional errors, however, do not detract from the volume's usefulness.

Although other reference sources contain much of this information (*Handbook of American Women's History* [Sage, 2000], *The Reader's Companion to U.S. Women's History* [Houghton, 1998], *Encyclopedia of Women's History in America* [Facts On File, 1996], *Women's Rights in the United States: A Documentary History* [Greenwood, 1994]), Kuersten's volume is more current and focuses on women in the legal and political arenas. It should prove useful in academic and large public libraries. *RBB*
